



**RESOLUTION DECLARING COST
AND ORDERING PREPARATION OF PRELIMINARY ASSESSMENT ROLL AND SETTING
TIME AND PLACE FOR PUBLIC HEARING ON PRELIMINARY ASSESSMENT ROLL
FOR WATERLINE IMPROVEMENTS FOR POND ISLAND**

WHEREAS, written requests were received from some property owners with frontage abutting on W. Shore Road and within the Pond Island Marina Subdivision for the Town to extend the public water distribution network to serve their properties; AND

WHEREAS, on March 5, 2014 the Town of Nags Head Board of Commissioners by motion decided to proceed with a special assessment against benefited property owners for properties along W. Shore Road and within the Pond Island Marina Subdivision for extending the public water distribution network.

WHEREAS, the undertaking of the said project was ordered by Resolution of the Town of Nags Head Board of Commissioners adopted on March 5, 2014 and has been completed in accordance therewith; AND

WHEREAS, the cost of the Waterline Improvement Project has been determined.

NOW, THEREFORE BE IT RESOLVED by the Board of Commissioners of the Town of Nags Head, North Carolina:

1. That the cost of the above described improvement has been computed and determined and is hereby declared to be **\$14,822.50**.

2. That the Town Clerk is hereby directed to prepare a Preliminary Assessment Roll, in accordance with Chapter 160A, Section 227, of the General Statutes of North Carolina, showing the individual assessments upon properties benefited by said improvement.


3. That the Town Clerk is hereby directed to make available during regular office hours, in her office, the said Preliminary Assessment Roll for the purpose of inspection by the public from July 16, 2014 through August 5, 2014.

4. That the Board of Commissioners will hold a public hearing in accordance with Chapter 160A, Section 228, of the General Statutes of North Carolina, at 9:00 a. m. on August 6, 2014 in the Board Room of the Nags Head Municipal Complex for the purpose of hearing all interested persons who appear.


5. That the Town Clerk is hereby directed to issue a public notice of the completion of the assessment roll and of the above described public hearing, which notice shall conform to the requirements of Section 160A-227 of the North Carolina General Statutes and is to be published on July 24, 2014 and on July 31, 2014, and to secure publisher's affidavit certifying the advertisement of said hearing.

6. That the Town Clerk is hereby directed no later than 10 days before the public hearing to mail by first class mail copies of the notice of hearing on the Preliminary Assessment Roll to the owners of property listed thereon, which notice shall conform to the requirements of Section 160A-227 of the North Carolina General Statutes, and the Town Clerk shall then file a certificate with the Board of Commissioners showing such notices were mailed by first-class mail and the date on which they were mailed.
