Re: Request for Budget Amendment – Street Sweeper

As the Board is aware, a street sweeper is included in the five-year capital improvement program to be purchased in FY 2023. Public Works needs to replace the existing broomstyle sweeper with an updated street-style sweeper, with the appropriate width to be used on the multi-use paths. The existing broom sweeper is no longer feasible to use on the multi-use path as it is not possible to operate in the overnight or early morning hours. The equipment is not lighted and produces a dust cloud which limits the operator's ability to see. It is no longer viable to sweep during the daylight hours as the path is consistently being utilized by walkers and bicyclists.

In anticipation of this future need, in the Fall of 2020, Public Works had representatives from Schwarze Industries and TYMCO onsite to demonstrate sweepers that could be utilized for both sweeping of the curb-and-gutter along S. Croatan Highway, as well as sweeping the multi-use path along both S. Croatan Highway and S. Virginia Dare Trail. These new sweepers are equipped with headlights for use in dark conditions. They also wet and vacuum the material, thereby minimizing dust emitted from the equipment. This sweeper is necessary not only for the aesthetics of the Town, but more importantly, the safety of all users on the multi-use path as the sand on the path creates potential hazards if left unaddressed.

Staff has identified funds to move the purchase of the sweeper into this fiscal year (see budget amendment). Attached is a product brochure and quote for the unit that we would like to purchase. Currently the lead time is 120 days. Therefore, purchasing now would allow us to have the unit prior to Memorial Day of 2022. Public Works asks for your consideration to purchase this much-needed piece of equipment.


